

DEER PARK ISD – PARENT PORTAL AGREEMENT FORM

A. Rights and Responsibilities

I understand that

- Deer Park ISD's Parent Portal is a complimentary "as is, as available" service. A parent or other person having legal access to a student's educational records must have a child actively enrolled in a campus within the district to be eligible for a Parent Portal account. Once a student withdraws or graduates from the District, Parent Portal access to that student will be inactivated. I understand and agree that this authorization remains in effect until I revoke by means of written notice or upon withdrawal of my child from Deer Park Independent School District.
- in order to have access to the Parent Portal system, my name must be on file in the District's student information system as a parent or other person having legal access to a student's educational records of the child I am requesting access.
- to request access to any additional children I will be required to repeat the full process of student access request, verification, and approval.
- I release the District from any and all liability for damages or harm arising out of unauthorized access to my Parent Portal account.
- as new functionality is added to the Parent Portal, these terms and conditions will be updated. It is my responsibility to review the agreement form periodically to ensure compliance.

B. Use of the System

I understand and agree that

- as a user of the Parent Portal system I am required to follow all rules and regulations outlined in the District's Electronic Network Use Agreement found online at the District's web site. I will practice proper and ethical use of the system.
- the User ID and password must remain confidential. I agree that I will not share my password nor allow anyone other than myself to use the account, including my own children.
- the use of this site by individuals other than me is not allowed and can result in the deletion of my account and deactivation of Parent Portal access.
- I will not harm or destroy nor attempt to harm or destroy the District's network or data or data of another user.
- I will not gain unauthorized access to information or use any account of another user; nor will I attempt to gain unauthorized access or attempt to use any account of another user.
- in the event I identify a security problem within the Parent Portal system, I will notify my child's school immediately without demonstrating the problem to anyone else.
- in the interest of security, the District reserves the right to change user passwords or deny access at anytime.

C. Information Responsibilities

I agree

- that all information provided by the Parent Portal system should be used for reference only and in no way should be used as a substitute for official District documents and/or records.
- to protect any information printed or transferred to my computer, and/or destroy the documentation generated from this site if necessary.
- that information accuracy is the joint responsibility between school(s), parent(s)/guardian(s), and student(s). Each school will make every attempt to ensure information is accurate and complete. If I discover any inaccurate information, I will notify my child's school immediately and provide proof of the inaccurate information.

I affirm that I am the parent or other person having legal access to a student's educational records of the child, in which Parent Portal access has been requested. I hereby authorize Deer Park ISD to post my child's information on the Deer Park ISD Parent Portal. I have read, understand, and agree to the Parent Portal access agreement as set forth by Deer Park ISD.
